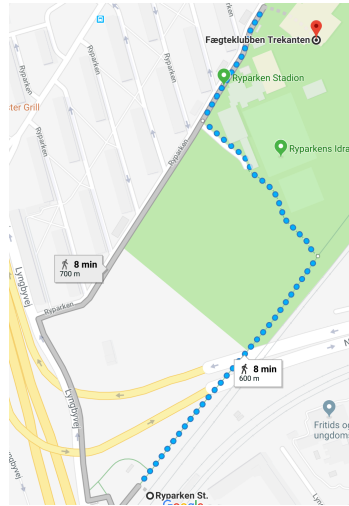

WEAPON CONTROL	Masks, Electric vests (max. 2)	
REFEREES	<p>The rules apply per club and per day:</p> <p>1-4 fencers = 0 referee</p> <p>5-8 fencers = 1 referee</p> <p>9-12 fencers = 2 referees</p> <p>13-16 fencers = 3 referees</p> <p>17-20 fencers = 4 referees</p> <p>21 or more fencers = 5 referees</p> <p>All referees must be available throughout the competition day. A fine of 150€ or 1000 DKK must be paid for each referee the club is unable to present.</p>	
FEE	€30 or 225 DKK per entry to be paid cash, credit card or mobile pay at registration desk.

COVID 19 RULES	<p>In accordance to the decision of FIE COMEX, following measures will be implemented during competition:</p> <ul style="list-style-type: none"> - Obligatory Facemask wearing, except when fencing, training and eating. - All participants will need to present the organizers with the negative result of one Covid-19 test (PCR or RAT – Rapid Antigen Test), performed within maximum 72 hours before arriving in Denmark. <p>If the COVID-19 situation gets worse FIE might revise measures, in which case the above will be revised accordingly.</p> <p>We remind you to have “COVID-19 ACKNOWLEDGEMENT OF RISK AND RELEASE FROM LIABILITY” (enclosed Appendix A) prepared and presented upon entry to competition for all direct or indirect participants.</p>

COVID-19 ACKNOWLEDGEMENT OF RISK AND RELEASE FROM LIABILITY

I voluntarily agree to assume all of the above risks and take full responsibility for any injury (including, but not limited to, physical injury, disability and death), illness, damage, loss, claim, liability or expense of any kind that I may suffer or incur as a result of my participation in the Tournament. I hereby undertake to refrain from suing the EFC and its designated individuals, including, but not limited to, members of the Directoire Technique, Refereeing, Referees, Armourers, supervisor, Video & Wireless Technicians, Announcers, Event Managers, etc. and the Organisers and the employees, agents and representatives thereof, whom I release from all liability.



I understand and agree that this release includes all claims based on the actions, presumed omissions and negligence of the EFC and its designated individuals, including, but not limited to, members of the Directoire Technique, Refereeing, Referees, Armourers, supervisor, Video & Wireless Technicians, Announcers, Event Managers, etc. and the Organisers and the employees, agents and representatives thereof, regardless of whether the COVID-19 infection occurred before, during or after my participation in the Tournament.

The release from liability shall be accepted subject to the substantive and/or mandatory laws of the country in which the event is taking place. I agree that, should any part of this agreement be deemed to be invalid or unenforceable, the remaining parts shall remain fully in force. This document shall be governed by the law of the Country of Luxembourg and any legal action brought hereunder shall be brought in the courts of Luxembourg, which shall have exclusive jurisdiction of any such legal action.
